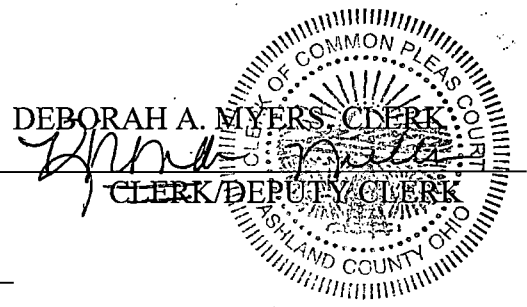

The penalties for a violation of your Personal Recognizance Bond are the following:

- 1) You may be fined not more than \$5,000;
- 2) You may be imprisoned in the penitentiary not less than six months, nor more than eighteen months;
- 3) You may receive both of the above penalties.
