PERSONAL RECOGNIZANCE

Terms and conditions: Defendant not to leave the State of Ohio. Defendant shall appear at all future hearings in this case. Defendant shall keep the Court informed of current address and telephone number at all times. Defendant shall follow and obey all orders of the Court. THE DEFENDANT SHALL SIGN A PERSONAL RECOGNIZANCE. AFTER POSTING BOND, THE DEFENDANT SHALL IMMEDIATELY REPORT TO THE COURT'S BAILIFFS, WHOSE OFFICE IS LOCATED ACROSS THE HALLWAY FROM THE ASHLAND COUNTY CLERK OF COURTS, FOR ENROLLMENT IN THE COURT'S DRUG TESTING/BOND PROGRAM. THE DEFENDANT SHALL HAVE NO CONTACT, WHETHER DIRECT OR INDIRECT, WITH EMILY O'BRIEN. THE DEFENDANT SHALL HAVE NO CONTACT, WHETHER DIRECT OR INDIRECT, WITH ASHLAND WALMART.

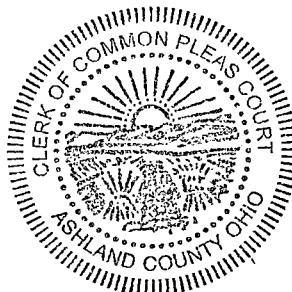

The penalties for a violation of your Personal Recognizance Bond are the following:

- 1) You may be fined not more than \$5,000;
- 2) You may be imprisoned in the penitentiary not less than six months, nor more than eighteen months;
- 3) You may receive both of the above penalties.
